

100 Schools Join Verizon Innovative Learning

Continued partnership between Digital Promise and Verizon provides free technology and internet access to select middle schools nationwide

MARCH 4, 2020 | **Washington, D.C.** – One hundred middle schools from 20 districts across the country will join the Verizon Innovative Learning Schools network in the 2020-21 school year. The continued partnership between Digital Promise and Verizon Innovative Learning equips every student and teacher at select middle schools across America with a device and up to a four-year data plan. In addition to technology and access, schools receive extensive professional development that supports powerful teaching and learning with technology in and out of the classroom.

Since 2014, as part of Verizon's commitment to digital inclusion, the Verizon Innovative Learning Schools initiative has impacted 153 middle schools in 23 states and Washington, D.C. The 100 new schools joining the program this fall will bring the total to 253 middle schools nationwide. Moreover, eight districts—Alhambra and Glendale Elementary School Districts in Arizona; Compton, Los Angeles, and San Francisco Unified School Districts in California; Jefferson County Public Schools in Kentucky; Mater Academy and Miami-Dade County Public Schools in Florida; and New York City Department of Education—will expand their participation in the initiative, with additional schools joining others that were part of earlier cohorts.

In addition to free mobile devices (either iPads or Chromebooks) and accompanying 4G LTE data plans, participating schools receive a subsidy toward a full-time technology coach to support teachers with effectively integrating technology into learning. Over the course of the initiative, students also will have the opportunity to learn about emerging technology such as augmented and virtual reality and 3D design.

"Student engagement and learning improve when technology is used in powerful ways," said Karen Cator, president and CEO of Digital Promise. "Through our partnership with Verizon, we're pleased to continue to support the access which this initiative provides to students who need it the most."



"We believe the Verizon Innovative Learning program can be a catalyst in the lives of middle school students across the U.S. by delivering transformational technology, education, and opportunity," said Justina Nixon-Saintil, director of corporate social responsibility at Verizon.

Participating schools use technology to meet the needs of each student and empower them with skills such as critical thinking, problem solving, collaboration, and creativity. Teachers in Verizon Innovative Learning Schools have reported exploring new ways of teaching and experiencing enhanced student engagement, while more students believe that having technology improves their confidence in the things they can do.*
